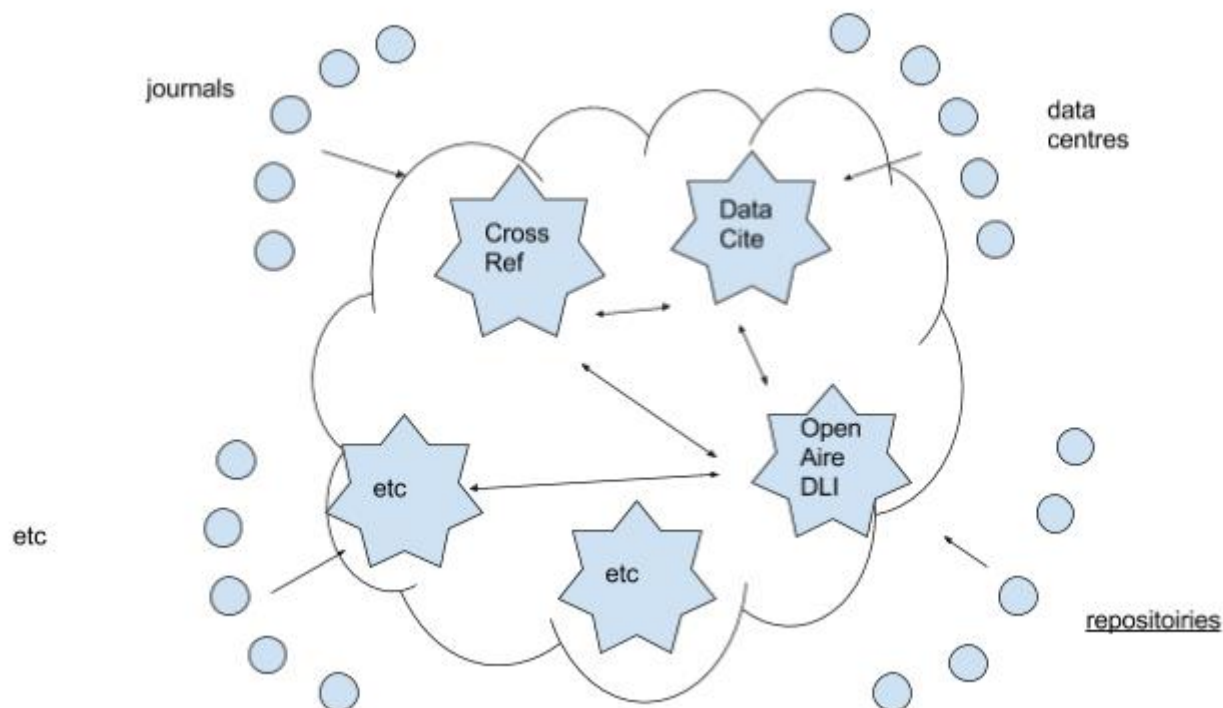

CRITERIA	DEFINITION	IMPORTANCE	VALUE(S) FAIRSHARING WILL CURATE AND DISPLAY	VALUE(S) TO BE USED FOR FILTERING
<b>Repository Status</b>	The life cycle status of the repository: is it still being developed or in production and accepting data submissions?	<i>Essential</i>	- 'Ready' (production-level). - 'In development' (actively being developed but still not ready for use). - 'Deprecated' (no longer maintained or superseded). - 'Uncertain' (when the life cycle position is unclear).	Status 'ready': Only production-level repositories will be selected.
<b>Data Access Condition</b>	Data access terms at repository level: how does one get to the data? For example, if the data is freely available or subject to a request and approval process.	<i>Essential</i>	- Presence 'yes', or absence 'no'. - Type of condition, e.g. 'open', 'controlled' - URL to the condition information.	Presence (yes): Only repositories that make access condition clear will be selected.
<b>Data Reuse Condition</b>	License or terms of use for reuse of existing data in the repository: what are the conditions, if any, under which one can reuse the data?	<i>Essential</i>	- Presence 'yes', or absence 'no'. - Type of condition. - URL to the condition information.	Presence (yes): Only repositories that make data reuse condition clear will be selected.
<b>Data Deposition Condition</b>	Deposition of data: are there any restrictions (e.g. by location, country, organization, etc.) or can anyone from anywhere deposit data?	<i>Essential</i>	- Presence 'yes', or absence 'no'. - Type of condition. - URL to the condition information.	Presence (yes): Only repositories that make data deposition condition clear will be selected.
